Annual General Meeting Procedures: To attend, you are required to complete 2 forms of preregistration. If you are an RVBIA member, you are eligible to vote (see restrictions below) and will need to complete both **the Zoom meeting pre-registration** and the **member pre-registration** which requires proof of BIA membership (photo ID and either a business card, utility bill with business name/tenant name and address, or City of Toronto property tax bill) available at the link above. **Voting Eligibility**: Per the City of Toronto Municipal Code, Chapter 19, Business Improvement Area, only members of the proposed BIA and their legal representatives (proof required) are eligible to vote at the AGM. A "person" is defined by Chapter 19 to include "a corporation and the heirs, executors, administrators or other legal representatives of a person to whom the context can apply according to the law." No person in attendance shall have more than one vote.

Board of Management Nomination: If you are interested in being part of the Board in the coming term, please complete and submit the attached nomination form or via our <u>website</u>, by no later than **Monday, November 7, 2022**.
